- 2. Leadership (Dean Cheng)

  - Dean Cheng will be the Advisory Board liaison
  - Alex Haslam will announce Christopher to the Advisory Board and CBE
- 3. Graduate (Sofia Dermisi)
  - Recruiting efforts in the current COVID-19 environment
    - i. Offer scholarship packages to make offer more appealing
    - ii. Competitive scholarship package targeted towards the unemployed
    - iii. Concern about international students submitting I-20s
    - iv. Virtual Info Sessions
    - v. Faculty discussed increase in late applications
    - vi. Faculty agreed to waive GRE/GMAT requirement, Sofia will check with the Graduate School
    - vii. Faculty discussed contingency planning if our incoming class size is reduced significantly

- 2. Minimum number of 10 students was discussed
- viii. Sofia is in discussions with University of Regensburg on the MSRE curriculum changes
- 4. Undergraduate (Arthur Acolin and Rebecca Walter)
  - Undergraduate Affiliate Compensation Policy was discussed
    - i. For class sizes 31-50, an additional \$2,000 will be added to salary of affiliate
    - ii. Concern from Sofia was raised about tabling this policy for now
    - iii. Dean Cheng agrees the policy is reasonable
    - iv. Faculty voted unanimously to approve policy
    - v. Melissa will work with ISC to change Matt Disston's salary
  - Course buyouts for 2020/2021 academic year
    - i. Rebecca is requesting to buyout one course, RE 361
    - ii. Arthur is requesting to buyout one course, RE 401
      - Funding has been received to redesign RE 497 to include in the new UW Data Science Minor, Rebecca and Arthur will work to restructure RE 497 to better serve our students
      - 2. Pike approved both buyouts and will sign forms
  - New Undergraduate instructors
    - Julie Howe Pre-Doctoral Instructor proposed to teach starting Autumn 2020, RE 250 and RE 563
